Scope of application: designed for the manufacture of rubber products.

Characteristics of fire and explosion hazard: As per GOST 12.1.044 rubber belongs to the group of solid combustible materials with high smoke-forming ability. In the process of production and processing, when rubber is heated above 230 °C, it is possible to release volatile products, including marginal (ethane, propane) and unsaturated (ethylene, propylene) hydrocarbons, carbon oxides. Upon contact with an open fire, it ignites without explosion and burns with a smoky flame with the formation of a melt and the release of the above-mentioned thermal degradation products.

Transportation rules: All types of transport are covered.

Type of shipment via railroad: carload. When transporting rubber packed in various types of bags in railway cars, it is loaded into the car to full capacity without packaging: When transporting rubber packed in box pallets in railway wagons, pallets are installed in 2-3 rows in height in accordance with the requirements of GOST 21650.

Storage rules: Store the material in paper bags with a polyethylene liner in a dry storage room at a temperature not exceeding 30 °C:

- rubber packed in bags - in stacks no more than 1.2 m high;

- rubber packed in box pallets - stacks of 3-4 pallets in height

Neutralization, disposal, and burial of wastes: Waste unsuitable for recycling does not require neutralization, is subject to removal to places agreed with the bodies of the Ministry of Emergency Situations and Environmental Safety and the Federal Service for Supervision of Consumer Rights Protection and Human Welfare (Department of Rospotrebnadzor).

Warranty period of storage: 1 year from the date of manufacture
